Rental Terms & Conditions

1. Supervision

The renter agrees to provide responsible adult supervision at all times while the inflatable is in use. The supervisor must ensure all participants follow the posted safety rules and prevent unsafe behavior.

2. Safety Rules

- No flips, wrestling, roughhousing, or horseplay.
- No shoes, food, drinks, gum, candy, or sharp objects inside the inflatable.
- No pets on or inside the equipment.
- Do not exceed the recommended number of participants or weight limits.
- Separate children by similar age and size whenever possible.
- Do not move or reposition the inflatable after setup.
- Never allow anyone to climb or hang on the walls or netting.

3. Assumption of Risk

The renter understands that inflatable amusement equipment involves inherent risks of injury. By signing this agreement, the renter voluntarily assumes all risks associated with the use of the rental equipment for themselves and all participants.

4. Release of Liability

The renter agrees to release, waive, discharge, and hold harmless 417 Jump, its owners, employees, and representatives from any and all claims, demands, causes of action, damages, losses, expenses, or liability arising from the use of the rental equipment, except in cases of gross negligence or willful misconduct.

5. Indemnification

The renter agrees to defend, indemnify, and hold harmless 417 Jump from any claims, lawsuits, damages, attorney fees, or expenses resulting from injuries, property damage, or misuse of the rental equipment occurring during the rental period.

6. Weather Policy

Safety is our highest priority.

417 Jump reserves the right to cancel, delay, or discontinue a rental if weather conditions become unsafe, including:

- Sustained winds or gusts exceeding 15 mph
- Rain or standing water
- Lightning or thunderstorms
- Severe weather warnings
- Any conditions deemed unsafe by 417 Jump

If unsafe weather exists before delivery, the renter may reschedule the rental at no additional charge or receive a rain credit valid for one year.

If weather develops after delivery and setup, no refunds will be issued. A partial credit may be offered at the sole discretion of 417 Jump.

The renter agrees to immediately stop use of the inflatable and unplug the blower if severe weather approaches.

7. Equipment Responsibility

The renter accepts responsibility for the equipment from delivery until pickup.

The renter agrees to reimburse 417 Jump for damage caused by:

- Negligence
- Vandalism
- Food, drinks, gum, or silly string
- Pets
- Fireworks or open flames
- Sharp objects
- Unauthorized relocation of equipment

8. Cancellation Policy

Cancellations made at least 72 hours before the event will receive a full refund or credit.

Cancellations made within 72 hours of the event may forfeit the deposit unless due to unsafe weather as determined by 417 Jump.
